## Important events to be reported - Fondul Proprietatea SA (the "Fund"): Update on all litigations between a Litigant shareholder and the Fund

Franklin Templeton Investment Management Ltd. United Kingdom Bucharest Branch ("FTIML Bucharest Branch / The Fund Manager"), in its capacity as Sole Administrator and Fund Manager of the Fund, would like to update shareholders on all cases between Ioana Sfiraiala (the "Litigant") and the Fund, as set out in the table attached as an Annex to this report.

The Fund Manager would like to inform investors and shareholders that in file 40330/3/2012 on 17 December 2012 the Bucharest Court published on its electronic system (ECRIS) accessed directly at the headquarters of the Bucharest Court a short decision announcing that it ruled against the Fund and admitted the request of the Litigant to erase the mentions and registrations of the Extraordinary General Shareholders Meeting (GSM) Decisions nos. 1, 2, 8 and 9 of 6 September 2010 made by Trade Register. It is important to note that the decision issued by Bucharest Court is not irrevocable.

For the moment, only the short summary of the decision is available, but the Fund has appealed the decision, and the argumentation for the appeal will be finalized after the full decision is issued.

Nevertheless, for the avoidance of any confusion, the Fund Manager notes that the version of the Constitutive Act to which the Court decision relates is not the one currently in force. New versions of the Constitutive Act were approved by the Fund's shareholders with vast majority during the 29 November 2010 GSM, the 23 November 2011 GSM, the 4 April 2012 GSM and the 23 November 2012 GSM. Furthermore, new resolutions at the 25 April 2012 GSM and the 23 November 2012 GSM specifically reiterated the shareholders' approval of the objects of all the resolutions to which this Court decision relates; these were proposed by a shareholder and approved by the Fund's shareholders with a large majority.

Accordingly, FTIML will continue to manage the Fund in accordance with its management agreement with the Fund, with the current Constitutive Act, and with the shareholders' decisions, in collaboration with the Board of Nominees.

The Fund Manager will continue to update shareholders and investors of any further material developments in these files, and will continue to vigorously defend the interests of the Fund and all its
