Important events to be reported - S.C. Fondul Proprietatea SA (the "Fund"): Update on all litigations between Ioana Sfirăială (the "Litigant") and the Fund

Summary: The Bucharest Court ruled in favour of the Fund in the files no. 15963/3/2012 and no. 22045/3/2012 and rejected the request of the Litigant, a shareholder of the Fund, and ordered the Trade Register to mention the Resolutions 9, 10, 11 and 12 of the Ordinary General Shareholders Meeting of 25 April 2012. These resolutions approved: the 2011 dividend distribution; the Sole Director's 2011 annual report; and the ratification and adoption of resolutions no. 8 and 9 of 6 September 2010.

Full details: Franklin Templeton Investment Management Ltd. United Kingdom Bucharest Branch (the "Fund Manager"), in its capacity as Sole Administrator and Fund Manager of SC Fondul Proprietatea SA would like to inform shareholders and investors that, on 23 October 2012, the Bucharest Court announced that it ruled in favour of the Fund in filed no.15963/3/2012 and decided:

- To reject the objection raised by the Litigant that the Fund Manager cannot represent the Fund;
- To dismiss the request of intervention filed by the Litigant as unfounded;
- To oblige the Litigant to pay the legal fees incurred by the Fund for this litigation; and
- To order the Trade Register to mention several shareholder resolutions (as detailed below).

The resolutions involved are:

- (i) the Ordinary General Meeting of Shareholders ("OGM") Resolution no. 9 of 25 April 2012 for the approval of the Annual Activity Report of the Sole Administrator for the year 2011 and the financial statements for the year 2011,
- (ii) OGM Resolution no. 10 of 25 April 2012 for the approval of the dividend distribution for the financial year 2011,
- (iii) OGM Resolution no. 11 of 25 April 2012 for the ratification of OGM Resolution no. 8 of 6 September 2010 for the revocation of the previous members of the Supervisory Board and of the Directorate and OGM Resolution no. 9 of 6 September 2010 for the appointing of the first members of the Board of Nominees; and

- (iv) OGM Resolution no. 12 of 25 April 2012 for the adoption of OGM Resolution no. 8 of 6 September 2010 for the revocation of the previous members of the Supervisory Board and of the Directorate and OGM Resolution no. 9 of 6 September 2010 for the appointing of the first members of the Board of Nominees.

Please note that the Fund Manager acknowledged this information from the Bucharest Court's official website. The Fund Manager has not yet received any official documents from the Bucharest Court regarding the Court's decision.

Further updates on all cases between the Litigant and the Fund are set out in the table attached as an Annex to this report. The Fund Manager will continue to update shareholders and investors of any further material developments in these files, and will continue to vigorously defend the interests of the Fund and all its shareholders.
