Important events to be reported: SC Fondul Proprietatea SA ("The Fund") - Update regarding the litigations started by Ioana SFÎRĂIALĂ to block the registration of the GSM resolutions with the Trade Register

Franklin Templeton Investment Management Ltd. United Kingdom Bucharest Branch (FTIML Bucharest Branch or the Fund Manager), in its capacity of Sole Administrator and Fund Manager of the Fund would like to update shareholders and investors on the file no. 15963/3/2012 having as object the request of the shareholder Ioana Sfîrăială to block the registration with the Trade Register of a number of resolutions of the Ordinary General Meeting of Shareholders, including the one for the approval of the dividend distribution for the financial year 2011.

During the hearing held on 29 May 2012 the Bucharest Court has observed that Dan Cristian Bărbulescu, which is an intervenient in favour of Ioana Sfîrăială in this case, did not submit the original of proof of payment the stamp duty - he sent the proof by fax but the copy was not readable. Considering this the Bucharest Court has postponed the hearing for 5 June 2012, 2pm.

Further details about all cases started by Ioana Sfîrăială for which we received subpoenas from courts are set out in the table attached as an Annex to this report.

The Fund Manager will immediately inform shareholders and investors of any further developments in this case and will continue to vigorously defend the interests of the Fund and all its shareholders from adverse parties.
