Important events to be reported - Fondul Proprietatea SA (the “Fund”): Update on all litigations between a Litigant shareholder and the Fund

Franklin Templeton Investment Management Ltd. United Kingdom Bucharest Branch (“FTIML Bucharest Branch / The Fund Manager”), in its capacity as Sole Administrator and Fund Manager of the Fund, would like to update shareholders on all cases between Ioana Sfiraiala (the “Litigant”) and the Fund, as set out in the table attached as an Annex to this report.

The table has been updated with details of seven new cases, namely files no. 46287/3/2012, no. 46288/3/2012, no. 46289/3/2012, no. 46290/3/2012, no. 46291/3/2012, no. 46292/3/2012, and no. 46293/3/2012, and the latest news on the ongoing cases.

Also, please note that in file no. 7171/3/2012 the Litigant clarified during the hearing on 3 December 2012 that she understands to start the case against the Fund, Romanian State represented by Ministry of Finance, Romanian Government and Romanian National Securities Commission, asking the court to authorize a person to call a GSM in FP with the following agenda: to approve the annual financial statements that ended on 31.12.2010 and 31.12.2011; the presentation of the Directorate report for 2010 and 2011; the presentation of the Auditor’s report for 2010 and 2011; to approve the 2012 budget of SC Fondul Proprietatea SA; to complete of the statutory number of the Supervisory Board members of Fondul by appointing three new members; to approve the net profit distribution for the 2011 financial year and to agree upon the net value of the dividends and to approve a registration date in accordance with the legal provisions.

Finally, we would like to report that Manchester Securities, the largest shareholder of the Fund, has filed requests of intervention supporting the position of the Fund in another three cases, as follows:
- in file no. 15961/3/2012 Manchester Securities asks the court to reject the request of the Litigant and to order the Trade Register the registration of OGM Resolution no. 16 of 25 April 2012 for the adoption of the Investment Management Agreement, OGM Resolution no. 17 of 25 April 2012 for the ratification of all the legal acts concluded by FTIM Bucharest Branch as Sole Administrator of Fondul Proprietatea S.A. during 6 September 2010 - 24 April 2012, and OGM Resolution no. 18 of 25 April 2012 for the

adoption of all the legal acts concluded by FTIM Bucharest Branch as Sole Administrator of Fondul Proprietatea S.A. during 6 September 2010 - 24 April 2012;

- in file no. 15966/3/2012 Manchester Securities asks the court to reject the request of the Litigant and to order the Trade Register the registration of the Fund's OGM Resolution no. 13 of 25 April 2012 for the ratification of all OGM resolutions approved during 6 September 2010 - 24 April 2012 (other than Resolutions no. 8 and 9 of 6 September 2010), OGM Resolution no. 14 of 25 April 2012 for the adoption of all OGM resolutions approved during 6 September 2010 - 24 April 2012 (other than resolution 8 and 9 of 6 September 2010), and OGM Resolution no. 15 of 25 April 2012 for the ratification of the Investment Management Agreement;

- in file no. 42956/3/2012 Manchester Securities supports the position of the Fund and asks the court to reject the Litigant's request for suspending EGM Resolution no. 5/29 Nov. 2010 and EGM Resolution no. 1/23 Nov. 2011 (both for approving the Fund's Constitutive Act).

The Fund Manager will continue to update shareholders and investors of any further material developments in these files, and will continue to vigorously defend the interests of the Fund and all its shareholders.
