### **Update on all litigations between a litigant shareholder and Fondul Proprietatea SA (the "Fund")**

Franklin Templeton Investment Management Ltd. United Kingdom Bucharest Branch ("FTIML / the Fund Manager"), in its capacity as sole administrator and fund manager of the Fund, would like to update shareholders and investors on all cases between a minority shareholder, Ioana Sfiraiala (the "Litigant") and the Fund, as set out in the table attached as an Annex to this report.

In particular, the Fund Manager would like to inform shareholders that the Bucharest Court has ruled in favour of the Fund in files no. 20528/3/2013, 20518/3/2013, 20659/3/2013, 20529/3/2013, 20650/3/2013, 17690/3/2013, 19001/3/2013, 20661/3/2013, 17689/3/2013, 17906/3/2013, 20847/3/2013, 20657/3/2013 and 20665/3/2013, and annulled the requests entered by the Litigant against the Fund's GSM Resolutions (without the Fund being cited and thus without identifying the precise GSM targeted by the Litigant).

The Fund Manager will continue to update shareholders and investors of further material developments in these files and will continue to vigorously defend the interests of the Fund on behalf of all its shareholders.
