Update on all litigations between a litigant shareholder and Fondul Proprietatea SA

Franklin Templeton Investment Management Ltd. United Kingdom Bucharest Branch ("FTIML / the Fund Manager"), in its capacity as sole administrator and fund manager of Fondul Proprietatea SA ("the Fund"), would like to update shareholders and investors on all ongoing cases between a minority shareholder, Ioana Sfiraiala (the "Litigant") and the Fund, as set out in the table enclosed as an Annex to this report.

The Fund Manager would like to note that the Bucharest Court ruled in favour of the Fund in file no. 43424/3/2012 and rejected the Litigant's request for the annulment of the following General Shareholders Meeting Resolutions: Extraordinary General Shareholders Meeting Resolutions nos. 14, 15 and 16 and Ordinary General Shareholders Meeting Resolutions nos. 25, 26, 27, 30, 31, 32, 33, 34, 35 and 36 all from 23 November 2012.

The Fund Manager will continue to update shareholders and investors of further material developments in these files and will continue to vigorously defend the interests of the Fund on behalf of all its shareholders.
