**Important events to be reported:**

**Update on all litigations between a litigant shareholder and Fondul Proprietatea SA (the "Fund")**

Franklin Templeton Investment Management Ltd. United Kingdom Bucharest Branch ("FTIML / the Fund Manager"), in its capacity as sole administrator and fund manager of the Fund, would like to update shareholders and investors on all ongoing cases between a minority shareholder, Ioana Sfiraiala (the "Litigant") and the Fund, as set out in the table enclosed as an Annex to this report.

The Bucharest Court decided in favour of the Fund in file no. 17692/3/2013, having as object the Litigant's request for challenging EGM Resolution no. 2/04.04.2012 (for amending the Constitutive Act) and EGM Resolution no. 3/25.04.2012 (for subscribed share capital decrease) and a request for de-registration with Trade Registry of these resolutions. Thus, the Court decided to reject the Litigant's request, admitting the objection of the Fund that the Litigant has not proven to have the right to start such a case.
