¹ In accordance with the information published in the current report issued by Fondul Proprietatea on 25 April 2025, which can be consulted [here](#), the Fund informs its shareholders that the admission to trading on the SFS of the London Stock Exchange of all Regulation S GDRs (ISIN: US34460G1067; London Stock Exchange GDR trading symbol: FP.) representing ordinary shares of the Fund, with one GDR representing fifty shares, was cancelled as of 8:00 am (UK time), 25 April 2025.

² As per the Fund's Extraordinary General Shareholders Meeting Resolution no. 10/2 December 2024, published in the Official Gazette of Romania, Part IV, no. 393/29 January 2025, the 2025 buyback programme refers to the acquisition by the Fund of a maximum number of 320,000,000 shares and/or equivalent global depository receipts corresponding to the Fund's shares ("GDRs"). The duration of the 2025 buyback programme is until 31 December 2025. The shares repurchased during this buyback programme will be cancelled (the "2025 buyback programme").

³ Please note that, in accordance with art. 29 (4) of Law no. 243/2019 on alternative investment funds, as further amended by Government Emergency Ordinance no. 71/2024, the Fund may carry out own share buybacks operations, only once during a financial year, up to a maximum of 10% of the share capital.
