The Fund was established by the Romanian Government in 2005 and eligible claimants who lost property former communist governments were under awarded shares in the Fund in lieu of compensation. The Fund was listed on the Bucharest Stock Exchange in January 2011.



Where there is no trading activity in the 30 day period for listed investments, the unlisted valuation approach applies. Investments in unlisted companies are valued using either shareholders equity value per latest financial statements (proportionally with the stake held) or by using valuation methods in accordance with International Valuation Standards (fair value principles). Any holding going through an insolvency or liquidation procedure is valued at zero until the procedure is finalised.
