Annex - Valuation methods used for the securities and the monetary market instruments held by Fondul Proprietatea S.A. as at 28 April 2017

The valuation methods used for the computation of the NAV as at 28 April 2017, for the securities and the monetary market instruments held by Fondul Proprietatea S.A. are the following:

1. Listed companies on BVB traded within last 30 trading days: Closing Price
2. Listed companies on AeRo market (alternative trading system) traded within last 30 trading days: Reference price – Average Price
3. Listed companies with no trades within last 30 trading days: Shareholders' equity / share (from the annual financial statements prepared in accordance to Romanian accounting regulations or in accordance to IFRS), Fair value/share;
4. Unlisted companies: Shareholders' equity / share (from the annual financial statements prepared in accordance to Romanian accounting regulations or in accordance to IFRS), Fair value / share;
5. Companies in insolvency or reorganisation: Valued either at zero or at the value provided by an independent valuator;
6. Companies in liquidation/dissolution/ bankruptcy: Valued at zero;
7. Companies with negative shareholders' equity, unlisted, or listed but not traded within the last 30 trading days: Valued at zero;
8. Companies for which the annual financial statements of the previous year were not available 90 days after the legal term: Valued at zero;
9. Treasury bills: Acquisition price cumulated with the accrued interest receivable calculated for the period elapsed since the date of acquisition;
10. Listed government bonds: Fair value (reference composite price, including the cumulated interest);
11. Bank deposits: Bank deposit amount cumulated with the accrued interest receivable calculated for the period elapsed since its creation date.

Annex – Changes in the valuation methods used for the computation of the NAV of Fondul Proprietatea as at 28 April 2017

For the computation of the NAV as at 28 April 2017 for Fondul Proprietatea SA, the valuation methods used for the investments in the companies presented below changed and/or have been updated:

1) Alcom SA

For this company, the valuation method remained the same, namely Shareholders' equity per share, but the shareholders' equity amount was updated from Shareholders' equity as of 31 December 2015 (respectively Lei 113.5418 /share) to Shareholders' equity as of 31 December 2016 (respectively Lei 111.0012 /share) following the approval during April by the General Shareholders Meeting of this company of the financial statements for the financial year ended 31 December 2016. The total impact of this update on the Fund's NAV was a decrease of Lei 226,746.01.

2) Mecon SA and Palace SA

For these holdings, the valuation method has been changed from Reference price - Average price (respectively Mecon SA: Lei 4.50 /share and Palace SA: Lei 0.46 /share) to Fair value (Last available trading price) (respectively Mecon SA: Lei 4.50 /share and Palace SA: Lei 0.46 /share) because the shares of these companies were not traded during the last 30 trading days and the valuation based on the last available trading price is considered to reflect better the fair value of these holdings than their shareholders' equity per share (respectively Mecon SA: Lei 31.7207 /share and Palace SA: Lei 0.3592 / share). This change of valuation methods did not have any impact on the Fund's NAV.

3) Comsig SA

Following the decision of General Shareholders Meeting of this company on 18 April 2017 to approve the voluntary dissolution of the company, the valuation method has been updated from Fair value / share (Shareholders' equity as of 31 December 2015 adjusted with dividends declared/share) (respectively 3.2816 Lei/share) to Fair value/share (zero value). The total impact of this update of valuation method on the Fund's NAV was a decrease of Lei 248,269.45.
