- The publication by FSA on **3 September 2013** of the FSA Instruction no. 2/2013, amending the Instruction no. 5/2006 regarding semi-annual accounting reporting system, applicable to the entities authorized, regulated and monitored by the National Securities Commission (in the Romanian Official Gazette no. 559/03 September 2013);
- The publication on **9 September 2013** on the National Agency of Fiscal Administration ("ANAF") website of the IT program to be used for the reporting of semi-annual financial statements applicable to the entities authorized, regulated and monitored by the FSA and the publication of the new deadline for the submission of these financial statements to ANAF, respectively 18 September 2013;
- The obligation of the Fund to publish the semi-annual Report (including the semi-annual financial statements) within 45 days from the end of reporting period, meaning **14 August 2013** (date that is before the date of the publication of Instruction 2/2013), stipulated in the Bucharest Stock Exchange Code, Article 95 (1), applicable to the listed companies for the submission to the Bucharest Stock Exchange of the semi-annual report;
