In the present, the Fund Manager is in the process of unblocking a number of 4,985,760 shares belonging to the Romanian State.

The Fund Manager would like to remind the Fund's shareholders that as of 13 January 2012, following the new Constitutive Act's entering into force, the restrictions regarding the voting rights related to the number of shares held by the Fund's shareholders were eliminated. Thus, the voting rights as of 29 February 2012 were calculated taking into account the provisions of Art. 11 paragraph (2) of the Fund's Constitutive Act in force, namely *"The shares issued by Fondul Proprietatea grant the right to vote, each share grants one voting right."* 

Please note that in January 2012, following the removal of the voting restrictions, the following shareholders of the Fund sent an ownership disclosure regarding the number of shares held in S.C. Fondul Proprietatea S.A.:

- City of London Investment Management Company Limited ("City of London"),
- Manchester Securities Corporation ("Manchester") together with Beresford Energy Corporation ("Beresford"), as affiliates within the Elliott group of companies,
- Palade van Dusen Georgia.
